Town of Jaffrey, NH Transfer Station/Recycling Center Guidelines

- The Facility is open to all Jaffrey residents and non-resident Jaffrey property owners. Commercial and Industrial businesses may utilize the glass, plastic and paper recycling facilities only.
- All users must obtain a permit sticker from the Town Clerk's office, which must be displayed on the **passenger side of the user's vehicle**. Vehicles without stickers will not be permitted to use the facility. Permits are not transferable. If the vehicle is sold, remove the sticker to the best extent possible and return it to the Town Clerk's office with the proof of transfer. A replacement sticker will be issued. Stickers will also be available at the Transfer Station.
- Recycling is mandatory and users of the facility must separate materials as follows:
 -  **Aluminum Cans:** Cans should be rinsed out and placed in applicable bin.
 - Steel and tin cans:** Dispose with regular household trash. Watch for notices about recycling.
 - Glass bottles:** Place in appropriate bin. Leaded, tempered and window panes are disposed of with Construction and Demolition debris.
 - Newspaper:** Newspaper only. Paper should be kept clean and dry. Should be in paper or plastic bag and placed in appropriate bin.
 - Magazines:** Deposit in collection box.
 - Junk Mail:** Includes mixed paper, envelopes etc. Place in appropriate bin.
 -  **Cardboard:** Flatten and place in appropriate bin.
 - Paperboard:** Cereal, shoe, and detergent boxes- flattened. Pizza boxes, only if clean, are acceptable.
 - Plastic Milk Containers (#2 Plastic opaque):** Milk, juice, water jugs. Bottles must be rinsed out, tops removed and flattened. Labels can remain on.
 - Plastic Containers (colored #2 plastic):** Laundry detergent, shampoo, soap. Bottles should be rinsed out, tops removed. Labels can remain on. Motor oil containers are **not** accepted for recycling.
 - Plastic Soda Bottles (#1 PET):** Clear and colored soda, liquor and juice bottles. Rinse out and remove tops. Labels can remain on.
 - Other Plastics (#3-6):** Currently the Town does not accept these items as recyclable plastics. Please dispose of with your normal household trash.
 - Waste Oil:** Engine and transmission oil only. No antifreeze, brake fluid, or transformer oil. No gasoline contaminated oil or other oil contaminated with foreign substance. Oil should be in suitable container with secured lids. Give container to the attendant. Oil can also be recycled at the point of purchase. Retain unacceptable liquids for hazardous waste collection.
 - Vehicle Batteries:** See attendant regarding disposal or at point of purchase (if available).
 - Rechargeable batteries:** Includes lithium, NiCad, etc. See attendant regarding disposal.
 - Mercury Containing Items (thermostats, thermometers, switches, mercury button batteries):** These contain mercury and cannot be disposed of with the trash. See attendant for disposal.
 - Computer printer ink and toner cartridges:** Recycle at point of purchase (if offered) or with printer manufacturer. See attendant for additional disposal options that may be available.
 - Scrap Metal:** Includes all metal and white goods (appliances – see exception below). See attendant before placing items in metal pile.
 - Appliances- CFC:** Includes refrigerators, freezers, air conditioners, dehumidifiers or any other device containing CFCs – chlorofluorocarbons. There is a **\$15.00** fee per item to purge the refrigerant from these appliances. The fee is paid at the Town Clerk's office. Present receipt to attendant. Payment in the form of a check (no cash) may be made at the transfer station. Doors **must** be removed from refrigerators and freezers.
 -  **Tires:** Residential drop off only. See attendant before placing tires in trailer. Rims must be removed from the tire. Rims can be disposed of in metal pile. Proof of registration is required.

- **Brush, Untreated Wood:** Includes brush and slash 4 inches or less in diameter and end cross section of 24 square inches or less. See attendant before disposing of materials in burn pile. Dimensional lumber, plywood, pressure treated lumber, and other composite materials are disposed of with demolition materials.
- **Leaves:** Deposit in designated area.
- **Demolition Materials:** Dimensional lumber, treated wood, plywood, roof shingles, drywall, etc. Please check with attendants before disposing of these materials. Materials must be generated in the Town of Jaffrey and delivered by the resident. **Contractors working for residents cannot use the facility for disposal of refuse.**
- **Propane Tanks:** Please see attendant for disposal. There is a **\$5.00** fee per item to purge the remaining gas from the tanks. The fee is paid at the Town Clerk's office. Present receipt to attendant. Payment in the form of a check (no cash) may be made at the transfer station.
- **Fire Extinguishers:** See attendant for disposal.
- **Household Hazardous Waste Materials:** These items are not accepted at our facility. Please see attendant for schedule of disposal and location. The items collected include pesticides, oil based paints, paint thinners, household chemicals and waxes, harmful, hazardous, or toxic substances, mercury containing items such as mercury vapor light bulbs, thermostats, and thermometers. When in doubt, please see attendant.
- **Televisions, Computer Monitors and Microwaves:** Please see attendant for placement in recycling area. There is a **\$5.00** fee per item to dispose of these items. The fee is paid at the Town Clerk's office. Present receipt to attendant. Payment in the form of a check (no cash) may be made at the transfer station.
- **DVD, VCRs, TiVO and other video and audio play/record devices.** Effective 7/1/09 these items were banned from disposal with household trash. See attendant for assistance. There is a **\$5.00** fee per item to dispose of these items. The fee is paid at the Town Clerk's office. Present receipt to attendant. Payment in the form of a check (no cash) may be made at the transfer station
- **Cell Phones:** Deposit old phones in boxes at Transfer Station and Town Offices for appropriate disposal.



- **Wrapping Paper:** Because of its composition, this paper is not recyclable. Dispose with regular household trash.
- **Packing materials and peanuts:** Please see attendant regarding disposal.
- **Fluorescent Bulbs and compact fluorescent:** These contain mercury. See attendant for disposal.
- We are sorry, but the attendant **cannot** help with the disposal of heavy items at our facility.
- The following activities are **not permitted** at the transfer station/ recycling center (facility)
 - Hunting; Discharge of any firearm (except by authorized personnel)
 - Operation of off-highway vehicles
 - Operation of any vehicle except on the roadway in and out of the Facility and the areas immediately adjacent to the Facility to dispose of waste
- **"Dump-Picking" is not allowed.**
- Questions regarding the disposal of specific items can be addressed to the Transfer Station/ Recycling Center personnel.

Please pay fee at Town Clerk's office and present receipt to attendant. Payment in the form of a check (no cash) may be made at the Transfer Station.

- **Unacceptable Waste:** Harmful, hazardous, or toxic substances, medical or veterinary waste, sludge or septic waste or those items which may be deemed hazardous by the Town are not to be disposed of at our facility.
- **Paints:** Please see attendant regarding disposal.

Swap Shop Guidelines

(Operated by Volunteers - not operated by the Town of Jaffrey)

Hours: Varied - Please see Swap Shop Volunteer for hours

- The facility is open to all Jaffrey residents and non-resident property owners.
- There is NO CHARGE for leaving or taking items from the swap shop area. Donations are accepted with a limit of three large trash bags/boxes donated per person/week.
- NO Computers and accessories accepted. DVDs, CDs, Videotapes and audiotapes accepted.
- Items may be left or taken during the hours the Swap Shop is open.
- Generally, items to be accepted include: Toys, books, furniture, household items, building supplies, appliances in working order. Some appliances needing repair may be accepted but the nature of the problem must be annotated on the item. Final judgment on what is accepted is up to the Swap Shop volunteers on duty.
- **PLEASE – DO NOT LEAVE ARTICLES IF THE SWAP SHOP IS CLOSED.**
- If any item is not accepted and there is a question about how to dispose of it, contact the transfer station/recycling center personnel.
- Patrons can take up to ten items per person, per week from the Swap Shop. The intent is to make items available to all eligible persons and not to allow one or a few persons to monopolize the facility for personal gain. In this regard, the Swap Shop volunteers on duty have the right to refuse access to the facility for whatever reason.
- Personnel managing the Swap Shop reserve the right to not accept items.
- Personnel managing the Swap Shop reserve the right to decide how long an item will remain at the Swap Shop and how it will be discarded.
- Persons wishing to dispose of bulky and/or heavy items but are unable to transport them to the Swap Shop, may place an advertisement on the Swap Shop bulletin board.
