I. The meeting was called to order at 7PM. Pat Weiner was appointed scribe. The minutes of March 24 were approved.

II. Correspondence

A. DES advised that a Shoreland permit for work on a driveway and two porches has been submitted by the property at 35 Fox Run Lane.

B. DES has accepted the Standard Dredge and Fill application from the Town of Jaffrey as complete to begin work on a new pump house. Randy Heglin is in charge of this project. The Zoning Board has approved the necessary variance.

C. The Harris Center will host the program "Taking Action for Wildlife Work Plan" on May 6, 7-9 PM.

D. The Monadnock Conservancy advised Con Com that its yearly monitoring of Children's Woods will begin soon. The Conservancy will be in touch with us with further information.

E. JB read excerpts from the Planning Board minutes re: the Miken Realty project on Ingalls Road. The Board is currently awaiting perc tests and further road cost estimates.

III. Treasurer's Report

The monthly report has been delayed. The report will show that no LUCT or Timber funds have been received this year to date.

IV. Priority Items

A. Open Space Ad-Hoc Committee

Two more meetings are scheduled. After these meetings, the issue will return to the Selectpersons who will decide whether or not to proceed to authorize the establishment of the OSC.

A. Lands and Trails

JB advised that he has made additional trail markers. They have not yet been placed.

This meeting has been scheduled for 5/12, 6:30PM at CG's home. NBB will also speak to Josh Penick regarding his assistance in refining the brochure presentation.
